In 2020, during the height of the COVID pandemic, 859 families received help through a total of 4,559 adult visits and 183 childcare visits (childcare offered January to March only). Alpha Grand Rapids provides four main types of services: medical, support, educational and material resources. In 2020, the Medical Services department provided 92 pregnancy tests, 47 ultrasounds for abortion-vulnerable women, and 15 STI tests. The Support Services department offers one-on-one mentoring (for women) and coaching (for men) through the Step Up Program, group learning and encouragement through the Single Moms Support Group and haircuts through the on-site client salon. In 2020, there were 1,489 hours of one-on-one mentoring and coaching as well as 1,956 "COVID resource emergency visits" for clients who were out of necessary resources such as diapers and formula. each household. Curbside deliveries or at home deliveries were conducted to ensure safety during the pandemic. There were 173 adult visits to the Single Moms Support Group in addition to 35 childcare visits to this program.

The Educational Services department at Alpha Grand Rapids offers a variety of classes including GED Completion, English as a Second Language, Spanish Support Group, Pregnancy Education and Parenting Class. A total of 135 people attended classes throughout 2020, with 837 visits. When classes were not permitted to meet in person, instruction went to on-line formats to help students continue progressing.

The Material Resources department meets crucial tangible needs of families in the community. In 2020, Alpha Grand Rapids distributed 83,200 diapers, 51,000 articles of clothing and 1,400 cans of formula, as well as many other infant and maternity necessities. A total of 161,000 items were earned by clients in our programs, at an overall value of \$340,268.
