The Educational Services department at Alpha Grand Rapids offers a variety of classes including English as a Second Language, Language Cafe, GED, Jobs For Life, Pregnancy Education and Parenting Class. A total of 147 students, both men and women, attended classes in 2024 with 1917 visits. Sch O.

Page 2, Statement of accomplishments, continued -The Support Services department offers multiple programs: one-on-one mentoring for women and coaching for men through the Step-Up Program, group learning and encouragement through the Single Moms Support Group, Grupo De Mamas Latinas, Fatherhood, and haircuts through the on-site client salon. In 2024, there were 3,678 hours of one-on-one mentoring and coaching as well as 284 women and 95 men a total of 379 "intro visits" for clients who have never been to Alpha and need resources such as diapers and formula. There were 298 adult visits to the Single Moms Support Group in addition to 990 hours of childcare for this program. For Grupo de Mamas Latinas we had 102 visits. There were 355 visits for Fatherhood Group classes. The Material Resources department meets crucial tangible needs of families in the community. In 2024, Alpha Grand Rapids distributed 205,308 diapers, 57,921 articles of clothing and 1,234 cans of formula, as well as many other infant and maternity necessities. A total of 113,326 items were earned by clients in our programs, at an overall value of \$491,208.
